CHOLSEY PARISH COUNCIL

Minutes of the Parish Council meeting duly convened and held on Wednesday 5th February 2020 in The Pavilion, Station Road, Cholsey at 7.30pm

Present were Mr M. Gray (Chair), Mr P. Jenkins, Mr J. Hope-Smith, Mrs V. Artenne, Mr D. Bamford, Mr C. Worley, Mr D. Seed, Mrs G. Herbert, Mrs I Neill, Mrs P. Turner and Mrs M. Dyer-Lynch.

179. To receive apologies for absence

Apologies for absence were received from Mark Smith.

180. To hear questions or comments from members of the public (max 15 mins).

A resident who has been a boater for 20 years and uses the Thames at Wallingford spoke about the proposed marina. He doesn't believe that the proposal would interfere with the rowers. All river users must exist together as they do at the moment. He believes the marina would be a viable business, provide employment and

trade for local businesses. It would be an asset and provide value to the community.

Mr Gray reported that Council has looked at the issues from all angles and considered the benefits as well as the problems. There has been a reduction of river frontage moorings.

Another resident asked if it is expected that the boats would come

from other marinas or be new boats? No idea.

181. To receive any reports from County and/or District Councillors

Mr Gray reported OCC has said the marina developer has to be allowed to give all their information, it's now in and will now come to planning committee.

OCC budget will be set next week. Looking better as settlement from central government is more generous. Likely to be a 3% increase.

Youth opportunity fund applications have been dealt with. Cholsey Youth Club has been successful in a bid to run drop-in sessions and outreach youth work.

The report from District Cllr Simpson was noted.

182. To receive Declarations of Pecuniary Interest for any agenda items

Mr Blandford declared a Pecuniary Interest in planning application MW.0033/18 as he is a neighbour.

Mr Gray declared a personal interest in P20/S0249/HH as he is a neighbour.

183. To approve and sign the minutes of the meeting held on 15th January 2020

The minutes were agreed and signed by the Chair.

184. To report Matters Arising from

a) The minutes of 15th January

Flooding outside The Red Lion is being dealt with. OCC is putting in a bid for the work and can't say when it will be done.

b) The Action Point Register

Solar Farm – Clerk to follow up.

Website is a real problem – need to see significant progress before next meeting.

185. Neighbourhood Plan pledges, commitments and upcoming development

Mr Seed updated Council on the proposed plan of area next to shops on The Forty. Need to confirm that OCC are happy with the drainage. Cost of removal of the pavement is an issue. Has looked a block paving and tarmac. Waiting for answer from County Council about drainage. Benefit would be three parking places.

Mr Worley is concerned the work would be against the Neighbourhood Plan policy of doing nothing to encourage more car journeys however there is a pledge to improve the centre of the village. Council will need to come to a decision about which policy to follow.

186. To adopt Terms of Reference for working parties.

Mr Gray reported that Council now have three working parties and a framework is needed for them to operate. The policy was discussed and agreed.

Proposed Mr Gray Seconded Mrs Neill Carried unanimously.

187. To discuss the future of weed spraying pavements using glyphosate in the village

Mr Gray noted that for many years Council has had weed spraying done to keep the pavements in good order. Always considered that as it is legal it is fine.

Mrs Herbert investigated details received from our contractor including risk assessment from national bodies. There is controversy about the risk of its use. Other systems available which are less damaging.

Mr Seed considered that Council needs to understand the extent to which the quantities used on the street are doing any harm?

The options were discussed.

188. To consider employing a street cleaner

Mr gray reported that the budgeted money for weed control could be used to employ someone to clean street including removal of weeds at two hours per week at £10 an hour probably weighting the hours towards the weed growing season. It may be possible to roll the job in with the OCC lollypop job to create a better job.

Mrs Neill proposed that Council stop using glyphosate and look to recruit a street cleaner for a trial period of a year.

Proposed Mrs Neill Seconded Mr Worley Carried Unanimously

189. Skate Park Update

Mr Worley has met with local objectors who are concerned about noise and anti-social behaviour to discuss the project. They also complained of lack of communication however there was plenty of publicity about the proposal. The group will look at noise mitigation as part of full planning application. SODC Planning Committee meet next Wednesday to consider the application.

190. Pavilion Extension Update

Mrs Turner and Mr Gray have met with GA who are project managing the extension. Work will start in the next week or so with the slab. In late March Pinelog will build extension. Should be complete by the end of June.
