## 66. To approve and sign the minutes of the meetings held on $2^{nd}$ June 2021.

The minutes were approved and signed by the Chairman.

#### 67. To note reports of updates from Action Point Register

The purchase of a monitor and stand for meeting was discussed. The advantages would be less paper and allowing councillors and members of the public to see planning applications clearly. Cllr Worley could sell his old monitor to the council which would be less expensive and give the opportunity to trial the format.

### 68. To note Clerk's Report

The planters on The Forty are covered by the council's public liability insurance but their individual value is lees then the excess on the policy.

The container has been ordered and the base completed. Volunteers are needed to put it together when it arrives.

The Estate Manager has a new laptop. Cllr Pomlett to assist with software for the allotments.

#### 69. To note the Skate Park status

Cllr Worley reported that the skate park is finished and already in use. The seeded areas need some protection – matting needed. Its very popular and council are very pleased. Official opening on 7<sup>th</sup> August – first aid booked and entertainment licence (until 8pm). Portaloos also to be booked.

Risk assessment needed for opening.

There have been further problems with the extension and the original build. Meeting with Pavilion Trust to discuss before taking further action. Potentially £100,000 of repairs needed. Clerk to take initial legal advice.

Cllr Hope-Smith asked for support to start a consultation within the council before taking it to residents and businesses.

## 73. To receive the internal auditor's report for the 2020-21 financial year

The internal auditors report was received and discussed.

The internal auditor gave a No response to Box B due to the overpayment of a staff salary. It was noted that although a new procedure had already been put in place to avoid overpayments in the future it would be sensible to investigate changing the bank mandate so that in future two councillors would have to confirm online payments.

The internal auditor gave a No answer to Box M as 31 days exercise of public rights were given. The Council agreed that as an extra day was offered (by mistake) that this did not alter the fact that the public did have 30 days of opportunity to inspect and ask questions about the accounts and did not give a No response to Box 4 of the Governance Statement.
