239. To receive apologies for absence

240. To hear questions or comments from members of the public (max 15 mins)

A member of the public spoke about her gate into the Ilges Lane allotments (minute 244). A discussion was held about the hedge and gates.

241. To receive any reports from County and/or District Councillor

Cllr Simpson highlighted some aspects of her written report. The housing land supply was also discussed.

243. To approve and sign the minutes of the meetings held on 2nd and 16th February 2022

Cllr Seed reported the Estate Manager had been in contact with someone who may be able to do work on the playground.

Cllr Bamford was not prepared to sign the minutes of the 2nd February 2022.

244. To discuss request from resident regarding gate into llges Lane Allotments

Cllr Bamford **proposed** that permission was given for this gate but this would be the last permission for a gate onto the allotments, it must be removed when the house is sold. It was agreed that council will work towards all the gates onto the allotments being closed. **Seconded** Cllr Neill **Carried** Unanimously

245. To discuss use of red telephone box on The Forty

The proposed plans for the telephone box were discussed. It was **resolved** to accept Cllr Ford's proposal and to allow different groups to use it for exhibitions.

246. To discuss Drs Surgery places for Cholsey residents

There has been no response from Oxford CCG. Robert Johnson MP asked a question in Parliament about Drs places in Oxfordshire. It was **resolved** to wrote to Mr Johnson and explain the issues in Cholsey especially provision for elderly people as there are poor transport links to Didcot and Goring where residents are being directed for Drs surgery places. It was agreed to invite Mr Johnson to attend the Annual Parish Meeting.

247. To plan Annual Parish Meeting

It was agreed to informally use the 19th March Coffee morning for the meeting and hold an exhibition in the Youth Room of the Neighbourhood Plan for consultation. Parish Councillors
