# Minutes of the meeting of Cholsey Parish Council duly convened and held on Wednesday 19<sup>th</sup> March 2025 at 7.15pm at The Pavilion, Cholsey

**Present were** Cllr J. Finch, Cllr G. Herbert, Cllr J. Hope-Smith, Cllr L. Nixon (Chair), Cllr K. Ofield, Cllr K. Pomlett, and Cllr S. Schäfer

Also present were C. Bird (Clerk); three members of public until 7.30pm; two members of the public to present a proposal regarding the skate park from 7.35pm until 8.10pm

#### 172. To receive apologies for absence

Apologies were accepted from Cllr D. Bamford, Cllr V. Bolt, Cllr J. Collins, Cllr P. Jenkins and Cllr M. Smith.

## 173. Public participation session: to hear questions or comments from members of the public (max. 15 mins)

Two residents attended to speak about water troughs on the Ilges Lane allotments; one resident attended regarding planning application P25/S0590/HH.

## 174. To receive Declarations of Personal or Pecuniary Interest for any agenda items (note, this does not preclude later declarations)

There were none.

# 175. To approve the Minutes of the meeting held on 19<sup>th</sup> February 2025 (Appendix A) and receive update on any Minute items

It was **resolved** to approve the Minutes of the meeting held on 19th February 2025 and they were signed by Cllr Nixon.

## 176. To receive any reports from County and/or District Councillors

The District Councillors' report was noted with thanks.

## 177. To hear a presentation from a local resident proposing further development of the Recreation Ground Skate Park

Two members of the skate park community presented a proposal for further development of the Recreation Ground skate park. The Councillors asked questions and it was agreed to form a working group to investigate the proposal further.

### 178. To note Clerk's report (verbal), in particular:

## a) To discuss next steps in deregistering the Land at Wallingford Road allotments

It was discussed that this land could support approximately 14 full size allotment plots. However it is believed not to have been active as allotments for decades, due to the distance from the village and its location by the bypass at the end of Wallingford Road, which was until recently 60mph. It also does not have a water supply.

It was **resolved** that if deregistering this allotment land is possible, then it will be managed for nature. Deregistering the land will also enable the Parish Council to charge the solar panel company for the access that is being provided across the allotment land to the solar plant.

The Clerk will write to the National Allotment Society to explain the Parish Council's position.

## b) To discuss next steps in response to a report by R.Ford on Ancient Local Pathways between Moulsford and Cholsey

It was **resolved** to support the proposal seeking to restore an ancient path between Moulsford and Cholsey. It was agreed that this should be taken forward by the Transport Committee, working with Moulsford Parish Council as appropriate.

The Clerk reported that Oxfordshire County Council (OCC) has now put speed limit changes in place, and are in the process of implementing parking restriction changes/line re-painting.

Cllr Collins has recently been informed that OCC intends to design and deliver a puffin crossing on Reading Road in 2025/26, subject to their Accessibility and Road Safety Budget being improved.

Councillors were encouraged to participate in the 'Let's Talk' Consultation for OCC's Wallingford Area LCWIP (Local Cycling and Walking Infrastructure Plan) which closes on 24th March.

It was **resolved** to make a grant of £22,000 to the Cholsey Village CIC towards the continued operation of the Happy Hub Children's Centre.

## b) To agree response to 2025/2026 grant request for the Cholsey Village CIC (contribution to Fun in the Park Summer 2025)

It was resolved to make a grant of £1500 to the Cholsey Village CIC towards Fun in the Park 2025.
